3. Declaration and consent

C. E. I consent to the **Organiser making medical decisions in emergency situations**, when it is not possible to contact me immediately — in the scope of providing first aid, calling emergency services, transporting to a medical facility, and giving consent to medical procedures necessary to save the Participant's health or life.

F. I declare that I provide the Participant with **transport** to and from the Elim Centre, and during the Event I am **available at the phone number provided** for contact regarding matters related to the Participant's participation in the School.

G. I consent to the **use of the Participant's image** captured during the Event in photographs and audio-video recordings — in accordance with Article 81 of the Polish Act of 4 February 1994 on Copyright and Related Rights — for the following purposes:

- use in informational and promotional materials concerning future editions of the School of the 70 and the Controller's activities.
